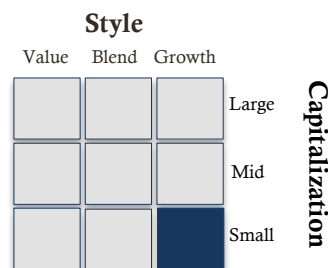

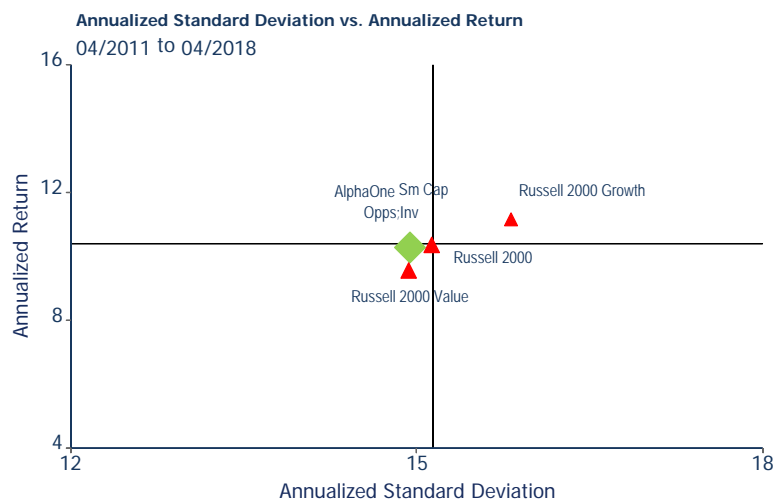
Investment Style

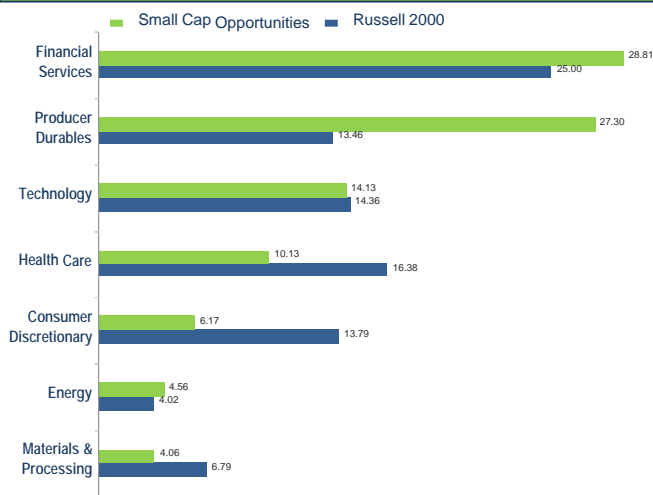

The Overall Morningstar Rating for a managed product is derived from a weighted average of the performance figures associated with its three-, five- and 10-year (if applicable) Morningstar Ratings metrics. The weights are: 100 % three-year rating for 36-59 months of total returns, 60% five-year rating / 40% three-year rating for 60-119 months of total returns, and 50% 10-year rating / 30% five-year rating / 20% three-year rating for 120 or more months of total returns. While the 10-year overall star rating formula seems to give the most weight to the 10-year period, the most recent three-year actually has the greatest impact because it is included in all three rating periods. As of March 31, 2018, AlphaOne Small Cap Opportunities Fund (AOMCX, AOMAX) was rated against 616 funds over a three-year period and 527 funds over the 5-year period. AOMCX received a rating of 4 and 4 stars for both periods. AOMAX received a rating of 3 and 4 stars, respectively. Standard deviation is a measure of the dispersion of a set of data from its mean. The more spread apart the data, the higher the deviation. Standard deviation is calculated as the square root of variance.
